### Notes (1)

Dmitry Evgenievich Samoilov is a Russian judge working in the Kovrov City Court. In that position, he repeatedly refused to address opposition politician Alexei Navalny's claims against the IK-6 correctional colony, aimed at restoring and protecting his rights violated by the leadership of the IK-6. Navalny's claims concerned access to medical aid, access to information, and the right to contact his family. Therefore, Dmitry Evgenievich Samoilov is responsible for serious human rights violations in Russia, including torture and other cruel, inhuman or degrading treatment or punishment, arbitrary detentions, and the systematic violation of freedom of opinion and expression.
