## Notes (1)

Musa Abdurakhmanovich Musaev is a Russian judge working in the Moscow Regional Court. In his position, he started legal proceedings regarding the arrest of Russian opposition leader Alexei Navalny upon his return from Germany, where he was receiving treatment for Novichok poisoning. He upheld the decision to arrest Navalny for 30 days, rejecting his appeal. The decision was made during a brief hearing that lasted only five minutes. Therefore, Musa Abdurakhmanovich Musaev is responsible for serious human rights violations in Russia, including torture and other cruel, inhuman or degrading treatment or punishment, arbitrary arrests and detentions, and the systematic violation of freedom of opinion and expression.
