Oleg Vladimirovich Sevostyanov is a high-level Russian official. He is Head of the Department of the Ministry of Justice of Russia for the YamaloNenets Autonomous Okrug. In that position, he is responsible for ensuring the protection of human and civil rights and freedoms in the Yamalo-Nenets Autonomous Okrug. The IK-3 penal colony, where opposition politician Alexei Navalny died and which is known for exerting physical and psychological pressure, full isolation, torture and violence on prisoners as well as the poor quality of medical services, is located in the Yamalo-Nenets Autonomous Okrug. Therefore, Oleg Vladimirovich Sevostyanov is responsible for serious human rights violations in Russia, including torture and other cruel, inhuman or degrading treatment or punishment, arbitrary detentions, and the systematic violation of freedom of opinion and expression.
