In that position, as he leads the state policy in the field of execution of criminal sentences and considers citizens' appeals, he was responsible for the execution of prison sentences of Russian opposition politician Alexei Navalny. Therefore, Vladimir Sergeevich Shvedov is responsible for serious human rights violations in Russia, including torture and other cruel, inhuman or degrading treatment or punishment, arbitrary detentions, and the systematic violation of freedom of opinion and expression.
