### Notes (1)

Vsevolod Lvovich Vukolov is a high-level Russian official. He is Deputy Minister of Justice of the Russian Federation. In that position, he is responsible for the supervision of the Federal Penitentiary Service and the Department of State Policy in the Field of the Penitentiary System. Accordingly, he was responsible for the execution of prison sentences of Russian opposition politician Alexei Navalny, his safety, and well-being in Russian prisons. As he oversaw the imprisonment of Alexei Navalny he is ultimately responsible for the death of Alexei Navalny in the IK-3 penal colony. Therefore, Vsevolod Lvovich Vukolov is responsible for serious human rights violations in Russia, including torture and other cruel, inhuman or degrading treatment or punishment, arbitrary detentions, and the systematic violation of freedom of opinion and expression.
